## ~ A guide for Alaska's small schools ~

### Pacific High School in Sitka would like your feedback on a school meals project:

There is a lot of buzz these days around improving school lunches, but if you're a small school in Alaska it probably seems distant, if not altogether absent. At Pacific High School in Sitka we're trying to bring that excitement closer and make change more accessible to our state.

We are creating an implementation manual that will guide small schools in Alaska in starting or improving their own lunch programs. As we move into the final stages of development we would like to solicit potential replication sites for feedback on manual content and implementation partnerships.

Our Healthy Lunch, Healthy Lives program is centered around a federally compliant lunch program where 1-4 students make nutritious lunches for the school from scratch on a daily basis. Our program is house run without the assistance of a contractor, and complemented by nutrition, gardening and culinary curriculum that cultivates students' connection to the food they eat every day. The implementation manual will cover everything from compliance and documentation to the basic culinary skills required to provide students with the best lunches possible. As we move towards publication, we want to make sure it includes everything YOU need to develop your own program.

## **SNA "Fed Up" Documentary Resources**

<u>"Fed Up"</u> opens in select theaters nationwide and through video on demand starting on May 9. Details and the trailer can be found at <a href="http://fedupmovie.com/">http://fedupmovie.com/</a>. The film, which is highly critical of the food industry, contains a 10 minute segment that negatively portrays foods and beverages sold in schools (some of the visuals are of competitive food choices).

While the film does outline the meal pattern changes, it rehashes the "pizza is a vegetable" controversy, quotes a student saying "it doesn't look like the choices have improved," and does not mention that upcoming competitive food standards will ensure the

candy, soda and high fat/calorie foods pictured in the film are not sold in school stores.



Fed Up's promoters are contacting school administrators to request that they host school screenings of the film, and SNA has provided extensive feedback encouraging that these screenings promote informed discussions about ongoing efforts to promote healthy school environments. However, SNA members should be prepared to respond to questions about the film.

SNA has created the following resources to help: talking points, a sample letter to administrators, and a customizable letter for parents. Now is a great time to promote the many benefits of school meals, so feel free to <u>download this flyer</u> to share with parents.



# Public Policy and Legislation

STATE PPL activities: The 2014 Legislature for the State of Alaska did authorize – pass the 2014-2015 capital item provision of \$3 million as support for the Nutritional Alaska Foods to Schools. (NAFS) On this 5/15/2014 date, the next step for this NAFS funding opportunity is awaiting the Governors final approval as included in the overall listing of capital budget items.



Should Governor Parnell again authorize the final OK for NAFS funding, it will establish the 3<sup>rd</sup> year of opportunities for the sponsors of USDA School meal programs serving Alaska children, to include Alaska sourced products as part of USDA school meal menuing.

The past successes of this NAFS funding does include the provision of Alaska cod, Alaska salmon, Alaska halibut, Alaska barley, Alaska produce, and Alaska sourced beef and pork products.

Bottled water is not yet allowed as a product supported with NAFS funding. As it appears to now be a time for consideration of NAFS support in the 2015 Legislative session, AKSNA is making an on-going effort to get bottled water included with the NAFS as an Alaska sourced item.

AKSNA will be looking for help from AKSNA members to share to our legislators the validity of bottled water as an allowable provision in NAFS.

National PPL activities: Please do go to the School Nutrition Association web site and review the very active efforts by SNA to share to the USDA and Congress the continued concerns about upcoming changes in required menunutrient practices.

AND; Huge Reminder—2015 is a year for reauthorization of the National School Lunch Act. This is another significant opportunity for considerations of funding and all things related to all parts of USDA school meal sponsorship.

SNA- AKSNA members need to make their expectations very clear to the USDA and Congress as we work through the reauthorization process.
