Alaska State Algency: Backfilling Vacancies with ChatGPT (AI)

Alaska's state agency has seen significant turnover this year. The Child Nutrition Programs Manager, NSLP Coordinator, SFSP Coordinator, and School Health and Wellness Specialist have all retired or moved on to new positions. Mason said that Department staff began feeding emails and responses to and from all of Alaska's state agency into ChatGPT and it was able to respond to technical questions and provide regulatory and policy guidance, sometimes even successfully. The State has entered into a five-year agreement with State Algency Solutions, LLC, a Cleveland-based company that has installed over seven different Stage Algency management plans. This will be State Algency's first Child Nutrition program; five of its clients are state Division of Motor Vehicles, and the other two clients are Medicare.

Nadia Botnit, State Algency's President and CEO said they have invested a substantial amount of time to prepare for their first Child Nutrition state agency contract. "We've spent over six workdays preparing for this contact," Botnit said, "I know that doesn't sound like a lot, but in computer time that's like two or three human lifetimes." "Only one decision remains," said Mason, "we're undecided whether or not the AI should have human names and lifelike 3-D avatars."

### **Personal Expert Eating Posse**

Personal Expert Eating Posse or PEEPs are here to save the day! This cluster of sweet food warriors are usually on found in the spring time, but through an agreement with their union, we may see PEEPs year round in every school kitchen. Known for keeping their dead eyes focused on pressuring you into one more bite of chocolate, PEEPS will use their powers of persuasion to get kids to try that squash and take those green beans. Not particularly known for their cooking savvy, PEEPs are quick learners and do not give up.

### Anchorage schools deploy Japanese-style vending machines in lieu of filling vacancies

After two years of struggle to staff its school cafeterias, the Anchorage School District announced all schools had fully re-opened school meal programs including breakfast, lunch, and CACFP suppers (where applicable).

ASD has invested in 55 Japanese-style vending machines to support its Student Nutrition Department and an additional unit is being tested by nursing staff. The 55 Japanese-style vending machines can serve hot, cold, and ambient-temperature foods and can fully comply with offer versus serve.

"We've got hot soups, chicken-in-a-can, pastas, ramens, and more," Vendi Meele, ASD Student Nutrition Director told Alaska's Snooze Source. "We have whole grain bread in a can, whole grain rolls in a can, and on special days, we have birthday cake in a can."

ASD's Purchasing Director Oupsy Daisy said that a typo resulted in ASD purchasing a vending machine that is now being tested by the District's nursing staff. "We wrote that we needed 'ambient' vending machines but I guess we accidentally missed the 't'," Daisy said, "So we got a machine designed specifically for medication and we can't return it because of the shipping cost, but then a nurse saw it and asked to use it to dispense over-the-counter medication."

Reporters attempted to call the nurse to ask how the Ambien machine is working but were told by school staff the nurse was sleeping.

### **Public Policy & Legislation**

### What's new?

Senator Lisa Murkowski's office has teamed with AKSNA to advocate to fully fund the Meals To You program for FY23-24, in addition to filing an Agriculture Appropriations Bill to try to block some impending USDA nutrition standard changes to the NSLP (88 FR 8050).

Senator Dan Sullivan's office is looking to introduce a bill (MAZ23102) in the Senate that would push more Alaskan seafood into school lunches across the country.

### Be in the Know!

USDA currently has a comment period that closes May 8th 2023 for the "Child Nutrition Programs: Community Eligibility Provision – Increasing Options for Schools", which would lower the minimum ISP from 40% to 25%. While this is an exciting prospect, here's what you need to know: lowering the ISP without increasing the multiplier can mean Local Education Agencies (LEA's) will pay a larger percentage to cover the cost of meals. We strongly encourage each district to counsel together and submit comments regarding this proposal. For more information, in addition to where to comment, please visit https://www.fns.usda.gov/cn/community-eligibility-provision.
